

Creative Commons licensing agreements

Creative Commons licences (<http://creativecommons.org/>) are agreements that allow publishers, like yourselves, to maintain copyright of their materials, whilst allowing users varying levels of access and use.

By opting for the Creative Commons-type licence, our readers will be able to effectively view precisely how you want your documents used, and potentially include documents in their similar collections.

The benefit of this is that your conditions remain constant and inviolable, but you do not have to engage in a new negotiation process about redistribution with every organisation which wishes to use redistribute the documents under the conditions you have specified in the licence. This allows, for example, your documents to be legally re-used in educational programmes, or redistributed.

For Hipatia Press, we are suggesting the "**Attribution non-commercial no-derivatives agreement**". This license is the most restrictive of the six main Creative Commons licenses. This license is often called the "free advertising" license because it allows others to download/copy your documents and share them with others as long as they mention you and (if on the web) link back to you, but they can't change them in any way or use them commercially.

A small graphic will be displayed appear under the link from the journal webpage. This will allow users to see that they may copy or distribute this document so long as it is attributed, not sold, and not changed. A link will also be provided to the full text of the agreement.

The research strategy has not been clearly disclosed. What research strategy was used? Is this an action research?

It is necessary to explain the age of the respondent. What age group are the research respondents from? are they high school age or college students? you must describe the profile of the participant. how old they are, their gender, so that the information obtained is clearer.

There is no description of the student's work yet. How do researchers evaluate student works? Has it shown good results?

There is no description of how the obstacles encountered. Then there is no picture of what if this method is used on students in high school. Is the use of this method also relevant in secondary schools?

Importance of the Subject

Reviewer's Comments (to be sent to the author):

The article deals with a subject of great didactic value, with a new resource that acts as the axis of the research. Due to the nature of the resource, the qualitative approach chosen and the research design are pertinent. The problem with this article, in my opinion, is that it does not sufficiently structure and describe the method used and the organisation of the results. Even though the participants are

adequate (over 40 for a qualitative approach is sufficient), qualitative research requires the extraction of deep meanings which are not sufficiently described in the results. I believe that the main problem lies in the fact that the analysis of the data does not describe the meta-categories and categories analysed, which makes the reading of the article incomplete. Likewise, the type of qualitative analysis followed and the possible tool used are not described in depth either. On the other hand, and taking into account the value of the information collected and that the authors have at their disposal, it would be essential to reinforce the exemplification and textual quotations of the work.
